### PUBLIC NOTICE OF DECISIONS: PROPOSED PLAN CHANGES 19, 22, 23, 24, 25, 26 AND A1.

#### Clause 10(4)(b), First Schedule, Resource Management Act 1991 (RMA)

#### Council decisions on submissions

At its meetings on 24 February 2011 and 7 April 2011, Council resolved to engage an independent Commissioner to hear and make decisions on submissions on proposed Council Plan Changes 19, 22, 23, 24, 25 and 26 to the Nelson Resource Management Plan (NRMP) and Plan Change A1 to the Nelson Air Quality Plan (NAQP). Nelson City Council gives notice that these decisions have now been made and received by Council.

Every submitter and further submitter has been served with a copy of these decisions. Under Cl.14 of the First Schedule of the RMA any submitter or further submitter may appeal any provision or matter that is the subject of their submission to the Environment Court within 30 working days of this service.

#### Summary of decisions

Decisions on each Plan Change are summarised below.

##### NRMP Plan Change 19 - Blackwood Street Reserve (West) Rezoning

Approve Plan Change subject to rezoning part of the land as Industrial Zone and an amendment that retains the remainder as Open Space and Recreation Zone.

##### NRMP Plan Change 22 - Heritage Trees

Approve Plan Change as notified with minor amendments to nomenclature of some listings.

##### NRMP Plan Change 23 - Daylight and Solar Panels

Approve Plan Change as notified without amendment.

##### NRMP Plan Change 24 - Freshwater

Approve Plan Change as notified subject to changes to the "priority for improvement" column in Appendix 28.4 to accurately reflect the new gradings.

##### NRMP Plan Change 25 - Technical Fixes

Approve Plan Change subject to:

- replacing the definition for "dripline" with "root protection zone" and consequential amendments to this term in the rules relating to heritage trees.
- reinstate the explanation to noise rules REr.43.5, ICr.42.5, SCr.36.5.
- removing a proposed matter of control from Rural Zone rules RUr.56.2 and RUr.80.2 (related to earthworks and subdivision within the landscape overlay); and replacing the word "requirement" with "guidelines" in rule RUr.80.2.

##### NRMP Plan Change 26 - Firefighting Provisions

Approve Plan Change subject to amendments to improve consistency with the NZ Fire Service Firefighting Water Supplies Code of Practice SNZ PAS 4509: 2008.

##### NAQP Plan Change A1 - Air Quality Plan

Approve Plan Change subject to adding a comma in rule AQR.25.1.a), and replacing the word "diesel" with the words "liquid-fuelled appliances" in rule AQR.23.
