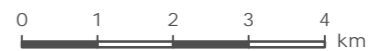

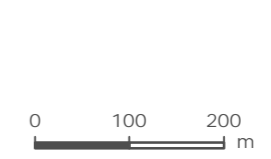

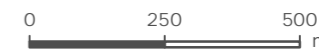

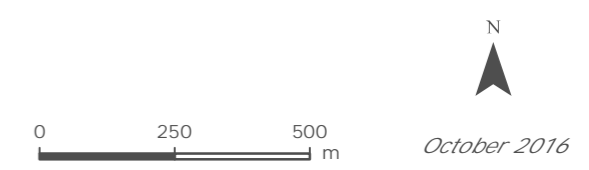


Proposed Tracks
 Map 7 - Maitai Dam



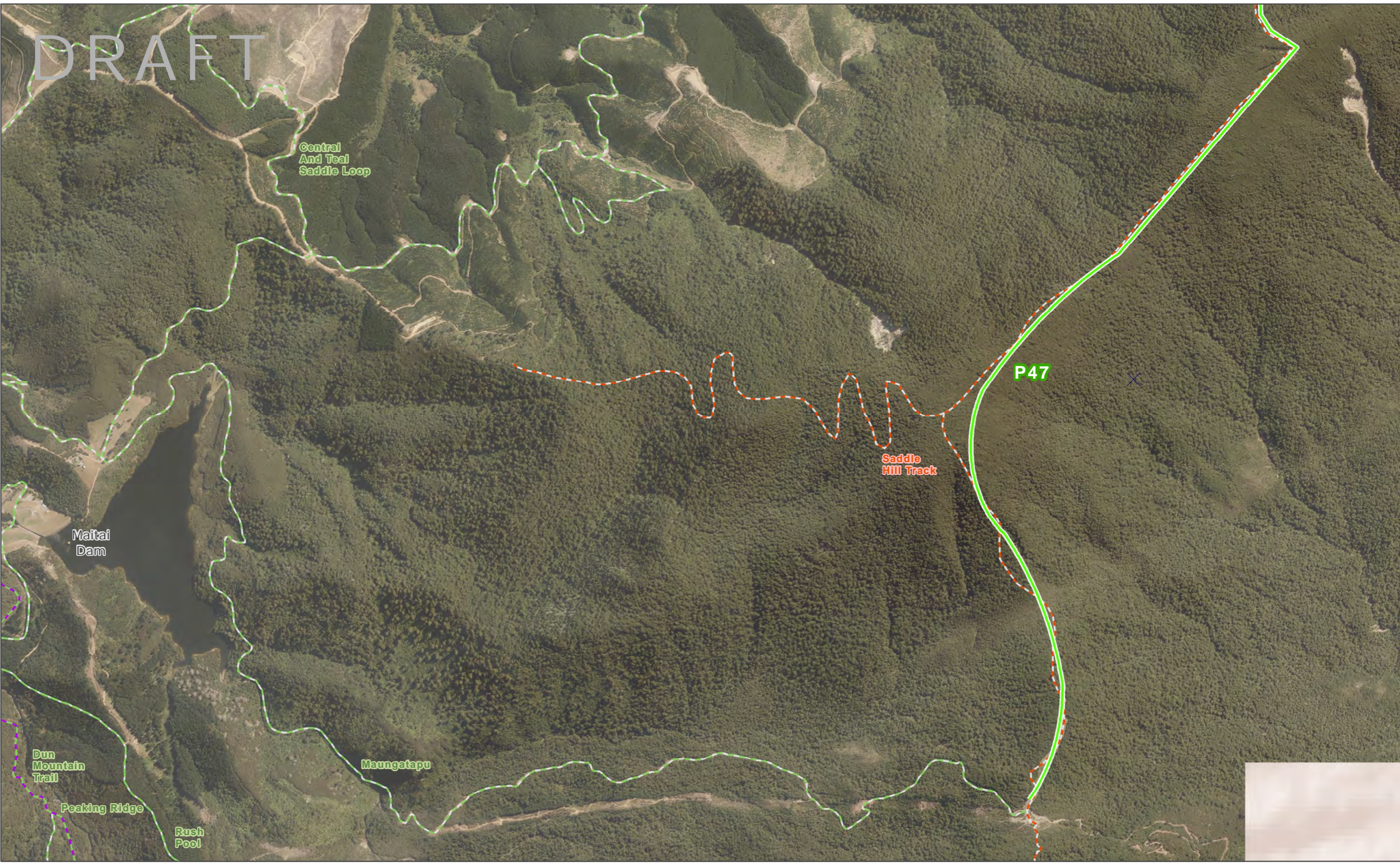
