It also provides that the Independent Member will be appointed by agreement between the two councils. For the last term of the Board the Independent member was Donna Hiser and she has indicated that she would be prepared to serve another term should the two Councils agree.

At the first meeting of the Board in December 2007 members agreed to elect Ms Hiser to the position of Chairperson, subject of course to her confirmation

as the Independent member.

Council has been advised that a recommendation was adopted by the Tasman District Council as its February meeting to the effect that her appointment for another term be confirmed.
