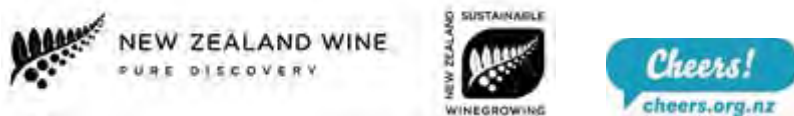

**NEW ZEALAND WINEGROWERS SUBMISSION**

***LOCAL ALCOHOL POLICY***

**1. INTRODUCTION**

New Zealand Winegrowers (NZW) is grateful for the opportunity to comment on the development of a local alcohol policy (LAP) for Nelson under the Sale and Supply of Alcohol Act 2012 (the SSAA). In this submission we set out some important considerations for the wine sector in the development of an LAP for Nelson.

***1.1 The New Zealand wine sector***

NZW is the organisation that provides strategic leadership for, and researches, promotes and represents the interests of, New Zealand grape growers and wine makers. Established in 2002 as a joint venture between the New Zealand Grape Growers Council and Wine Institute of New Zealand, NZW now has approximately 700 winery and over 800 independent grape grower members. Every grape grower and wine maker in New Zealand is a member of NZW. Accordingly, NZW is recognised as New Zealand's principal wine industry organisation.

Wine is a major productive sector and contributor to the New Zealand economy. It is the largest single horticultural crop in New Zealand. With annual export earnings of \$1.2 billion the New Zealand wine industry is now ranked as New Zealand's eighth most valuable export earner. The wine industry is also a major employer creating employment for more than 16,500 full time equivalent employees<sup>1</sup>. It is also a major tourism provider. In 2008, wine tourists numbered 475,300, comprising 177,700 international visitors, and 297,500 domestic tourists.

The grape and wine sector stretches from Northland to Southland, playing a pivotal role in many of New Zealand's regional economies.

Contrary to preconceptions about the "alcohol industry", the New Zealand grape and wine sector is not dominated by large companies or overseas ownership. 90% of New Zealand's 700 wineries and almost all of our 800+ independent grape growers are small to medium, family-owned businesses. All of our members have invested in New Zealand, have their families and lives in New Zealand communities and care deeply about the social and economic issues facing our country.

***1.2 Minimising harmful use of alcohol***

NZW and its members are committed to moderate and responsible consumption of wine. NZW is supportive of policies and programmes that effectively address the harms associated with the misuse

of alcoholic beverages, while also recognising that proper consumption of wine can promote health, social and cultural benefits.

Regulation has an important role to play in minimising harmful use of alcoholic beverages. However, it should not be seen as a “cure-all”; rather it should be seen as one of a suite of measures to address a complex problem that is fundamentally social rather than legal or political in nature. All stakeholders, including economic operators, have a role to play in minimising harmful use of alcoholic beverages, as has been recognised by the World Health Organisation.

Regulatory measures such as the licensing restrictions contained in local alcohol policies need to be proportionate and carefully tailored to address actual risks in effective ways. They should be based on sound evidence that is relevant to the situation at hand, rather than assumptions and knee-jerk reactions. They also need to be mindful of legitimate commercial interests and the economic, social and cultural benefits of safe and sensible consumption of alcoholic beverages. Otherwise, there is a significant likelihood that they will produce unintended negative outcomes, such as facilitating the development of localised monopolies and encouraging the growth of illicit sales. These were both features of the pre-1989 licensing system.

The wine sector recognises that it has a role to play in contributing to the minimisation of harmful use of alcoholic beverages. Measures taken by NZW include:

- Partnership with the Brewers Association and the Distilled Spirits Council in the Tomorrow Project, a social change initiative under the banner of the *Cheers!* brand ([www.cheers.org.nz](http://www.cheers.org.nz));
- Publication of a code of practice for winery licensees entitled “Cellar Doors and the Law: A Guide to Responsible Service”;
- A Code of Practice for Wine Events is currently under preparation in consultation with the Health Promotion Agency, the Police, and other stakeholders based on the successful Guidelines for Managing Alcohol at Major Events produced by the Health Promotion Agency and others;
- Recommendation and guidance to all members on use of pregnancy advisory labels;
- Participants in the Advertising Standards Authority’s “Code for the Naming, Labelling, Packaging and Promotion of Liquor”;
- A major PGP research project aimed at making New Zealand the global leader in low-alcohol low-calorie wine is in development; and
- Many members also have their own social responsibility programmes that include health advisory labelling, advertising and training programmes.

## **2. WINE PRODUCERS AND LICENSING**

### ***2.1 Nature of wine producers’ licensed premises***

Most wine producers are also licence holders. Wineries will usually take the opportunity to sell their products through the winery cellar door. This serves as the principal interface between wine tourists and winery and is typically the place where visitors can learn about the winery, the winemaking process and individual wine styles and characteristics. Many wineries will offer tastings only under an off-licence.

The range of activities which take place at the cellar door which can be described as wine tourism are not limited to cellar door sales. Wine tourism provides families and groups of friends with an opportunity to visit a vineyard and/or winery, eat a meal, take part in a tasting or share a picnic together and enjoy the scenic backdrop. These activities will often be covered by an on-licence.

In addition to cellar door operations, mail order is an important sales channel for small wineries. Mail order enables boutique wineries to directly convey their product to the market. This is particularly important to this category of wineries because it facilitates more flexible distribution given volume limitations, pricing and other factors. The winery mailing list and internet platform also provide small wineries with an important tool to connect with their winery cellar door visitors in an ongoing way. Even more importantly, these channels provide wineries with the ability to avoid the downward price pressures of selling through the large retail chains. We estimate that approximately a third of wineries in this category only use their off-licence to facilitate mail-order sales.

Local farmers' markets, A&P shows and galas provide small winemakers with the opportunity to present their products to a wider local audience in a positive context alongside other foodstuffs and local wares. In effect, these events can operate as an extension of the cellar door itself. Again, this is a very low risk activity in terms of harmful use of alcohol. Special licences are usually required for such events.

## **2.2 Winery licences are recognised as low risk**

Winery cellar door facilities are recognised as a very low risk class of licenced premises.

Even before the SSAA was introduced, a Cabinet Paper produced by the Ministry of Justice in June 2008<sup>2</sup> noted that: *"cellar door sales (including online and mail order) do not generally give rise to problems of excessive consumption or sale and supply to minors because small volumes are sold at high cost to discerning consumers, and are often not easily accessible or within the budget of young people; and consequently off-licence sales from wineries are a low risk environment."*

During the submission process for the SSAA, New Zealand Winegrowers gave extensive submissions on the impact of increases of licence fees on winery cellar doors. These concerns were partially recognised in amendments to the SSAA to reducing licensing requirements for winery off-licences by exempting them from having to have a manager on duty at all times when alcohol is being sold and introducing a regulation-making power to allow the Government to vary notification requirements for different types of low-risk licences (including winery cellar doors).

In its press release accompanying the supplementary order paper that introduced these changes, the Ministry of Justice noted that: *"Winery cellar door operations generally pose a lower risk of alcohol related harm than other types of licensed premises, and have high compliance costs in comparison to this level of harm. Winery off-licence premises also make an important contribution to regional tourism."*<sup>3</sup>

More recently, in its extensive consideration of factors for determining cost and risk profiles of licence holders as part of the Consultation Paper *Establishing a new fee regime for the alcohol licensing system* dated June 2013, the Ministry of Justice classified cellar doors as being in the lowest cost/risk category.

There are a number of reasons why winery licences are a very low risk category, including:

- a focus on tasting, rather than drinking (small serves, spittoons etc);
- products are from a single producer;
- rural setting (not a “hot spot”);
- limited trading hours;
- small volume of sales;
- high per-unit cost of products.

In general, wineries are settings within which behaviours of moderate and responsible consumption are promoted. Settings that tend to strengthen a positive culture in relation to the consumption of alcoholic beverages should be recognised and encouraged – for example, where wine and food pairing is a focus; the consumption of alcoholic beverages is in controlled environments and positive social settings; and where the consumption of alcoholic beverages is part of a broader consumption experience.

It is recognised that there have been occasions when wineries have been the subject of enforcement actions. However, these occasions are not typical and should be addressed as issues affecting the licensee in question rather than the category of wineries as a whole.

### **2.3 The cost of licensing compliance**

For most wineries, margins are extremely tight and profitability is a key concern. Compliance costs have a major impact on winery profitability. Such costs are generally higher for wineries than for comparable small and medium-sized businesses because wineries have the compliance costs associated with licensing and excise in addition to the compliance costs associated with an agricultural food production business. It is important to keep in mind that, unlike almost every other category of licensee, winery cellar doors pay excise directly to Customs before they have sold their product.

Compliance costs are cumulative; a fee or process that may seem reasonable or affordable from a regulatory perspective when viewed in isolation in fact forms one component of a far greater regulatory burden. Every new cost is very significant to a winery.

Compliance costs consist not only of fees that a business must pay but also the associated cost in terms of time and staff resource. While it is unclear as yet whether licensing fees will be set locally or nationally, it is clear that the administration associated with licensing measures under the LAP will create cost for wineries. NZW emphasises the need to be mindful of the need to minimise costs to winery licensees in the LAP.

In the case of winery cellar doors, it should be taken into account that such operations are conducted primarily as a marketing exercise rather than as a fully profitable retail outlet. They raise the profile of a winery, create an experience that resonates with consumers and provide means to build up a mailing list to remain in contact with their customers. In addition to low sales, winery cellar doors have a very limited product range due to their function as promoting a single winery. This means that the costs associated with licensing are not amortized across a wide range of products, as is the case with large retailers, but are borne by a low volume of sales across a limited product range.

### **3. INTERESTS OF WINERIES IN THE LAP PROCESS**

#### ***3.1 Differentiation between types of licensees***

The LAP should differentiate between types of licensee according to the level of risk, cost and social and economic benefits attributable to licensees of that type. This process will be necessary in any event as part of the process of setting risk-based licensing fees. The very low risk profile of winery licences, the profitability issues related to high compliance costs and the social and economic contribution of winery licensees to regional communities as a category should be specifically recognised in the LAP.

#### ***3.2 Specific provisions of the SSAA***

Section 215 of the SSAA creates an exception from the requirement to have a manager on duty at all times when alcohol is being sold or supplied to the public for winery cellar door off-licences. This was enacted to reduce costs for winery cellar doors in view of their low risk status. The section effectively defines winery cellar doors as:

*“premises for which an off-licence but no on-licence is held where fruit or vegetable wine or grape wine is made; and*

*premises for which an off-licence but no on-licence is held that are situated on land from which there is harvested produce from which fruit or vegetable wine or grape wine is made.”*

It is particularly important to note that this section specifically does not require that all wine sold is made at the premises or produced from fruit/vegetables grown on the site in recognition of the fact that wineries may need to source wine or fruit externally for a range of legitimate reasons.

Section 215 should be taken into account when developing an LAP.

#### ***3.3 Density controls and limits on the number of new licences***

Wineries often tend to cluster in discrete areas. While the clustering of vineyards and wineries is a result of favourable microclimatic, geophysical conditions and the availability of land, it also facilitates the accessibility and viability of wine trails and other tourism activities. Clustering therefore has a beneficial economic effect and, given the low risk nature of cellar doors, produces little or no additional risk.

Given these factors, it would not be appropriate to impose density controls or other limits on the issue of new winery licences such as regional or area specific caps. Such controls would serve only to

rob new entrants of a legitimate outlet for their products and ultimately stifle the growth of an important regional tourism asset.

It should be noted that the growth and concentration of winery licences are to a large extent self-limiting due to the fact that they will be situated either at a winery or on a vineyard which has significant cost and spatial implications.

### **3.4 Proximity to sensitive sites**

Licensing restrictions or discretionary conditions imposed on the basis of proximity to sensitive sites should reflect the relative risk profile of the applicant. While uncommon, it would not be entirely unusual to find a winery cellar door located in proximity to premises or facilities of a particular kind – for example, a rural school. Winery cellar doors are unlikely to produce heightened risk in proximity to possible sensitive sites due to factors such as their rural location, high cost per unit, low sales etc. Winery cellar door owners choose their sites for reasons related to both production and tourism and cannot easily relocate on the basis of proximity to a sensitive site.

### **3.5 Remote sales**

Websites and mail order are essential business tools for wineries – particularly small wineries. They allow producers who have difficulty in accessing nationwide and international distribution channels to reach a wider audience. Remote sales are closely linked to winery cellar doors because they provide an avenue to continue the relationship between winery visitors long after they have departed. In cases where a winery does not operate a cellar door, remote sales are the only avenue by which they can sell directly to the final customer. Remote sales by wineries are primarily intended for customers outside a licensing region. There is no evidence to suggest that remote sales from wineries are anything other than a low risk activity.

For these reasons, NZW submits that off-licences for remote sales by wineries be treated as integral to, or in cases where there is no physical cellar door as equivalent to, winery cellar door operations.

### **3.6 Special licences**

Special licences are integral to the wine sector. They allow wineries to be present at local farmers markets, to conduct wine tasting events, to participate in wine and food shows and to hold events such as concerts that serve to support their brands. It is essential to the wine sector that there is an equitable system that allows wineries in all areas to use all commercial opportunities available to them within the parameters of the SSAA.

Local farmers' markets, A&P shows and galas provide small winemakers with the opportunity to present their products to a wider local audience in a positive context alongside other foodstuffs and local wares. In effect, these events can operate as an extension of the cellar door and are similarly a low risk environment in terms of the harmful consumption of alcoholic beverages.

The cost of obtaining a special licence is often too high for small winemakers to access the marketing opportunity which farmers' markets and the like present. This is the cause of considerable frustration to many small winemakers. While the licensing fee regime is the subject of separate analysis, it is

important to note here that high costs and the imposition of overly stringent discretionary conditions materially reduce the marketing opportunities, and thus financial viability, of New Zealand's small winemakers.

Many wineries also host special events at their wineries, such as food and wine events and concerts. These are a very important means of promoting individual and regional brands and earning additional income for businesses that are often struggling for economic sustainability. New Zealand Winegrowers is preparing a Code of Practice for Wine Events in consultation with the Health Promotion Agency, the Police, and other stakeholders based on the successful Guidelines for Managing Alcohol at Large Events produced by HPA and others. Special licence conditions for wine events should take into account the Code of Practice for Wine Events.

### **3.7 Harmonisation of LAPs**

It is important that LAPs should be harmonised as far as practicable across licensing districts unless there are compelling risk-based reasons not to do so. This is particularly important across adjoining licensing districts. Almost all recognised wine regions in New Zealand cover more than one licensing district. It would be highly inequitable for wineries in a single region to have different licensing conditions simply because they cross licensing district boundaries.

### **3.8 Engagement with licensees**


License holders have a vital interest in the licensing process. The livelihoods of many businesses and the economic, social and cultural benefits that flow from them are at stake when licensing conditions are under consideration. Equally, there is considerable expertise and experience in operating licenced premises among licence holders that can be drawn upon to develop effective approaches to minimising the harmful use of alcoholic beverages.

For these reasons, it is essential that the council develops processes to engage with licence holder not only during the development of the LAP but on a continuing basis. This is even more important in the case of a very new policy such as the LAP. It is inevitable that the implementation of a very new policy will throw up unexpected situations and problems which can best be resolved through dialogue with all interested parties including licensees.

Hi,

Thank you for the opportunity to submit my perspective on alcohol supply and consumption in Nelson and comment on how Council has addressed these in developing a draft Local Alcohol Policy. My current role as Suicide Prevention Coordinator for Nelson and Marlborough identifies the increased risk to those with suicidal behaviours and the use of alcohol. Working in the area of health, I would like to re-iterate the known harms regarding this drug.

1. Alcohol is an easy drug to overdose on
2. Alcohol can cause brain damage
3. Alcohol can cause aggression
4. Alcohol can cause cancer.

I advocate for effective regulation and not prohibition or excessive free market for alcohol supply. I therefore strongly support reducing alcohol accessibility by limiting the density of licences by not issuing new licences and limiting the location of licences in particular areas/facilities, such as in specific neighbourhoods/schools etc. I support conditions being imposed on groups of licences such as a "one-way door" condition that would allow patrons to leave premises but not enter or re-enter after a certain time and limiting/reducing the trading hours for on and licences.

I believe that by introducing effective regulation as above, it will maximise the safety, health and well-being of our community.

Hello

I want to make a submission on the Draft Local Alcohol Policy.

A one door policy is suggested to resolve the problems caused by all people entering the streets at the same time after clubs close. I want to tell you about my experiences with a one door policy and why I am strongly opposed to the idea. I like you to consider this when you make a final decision.

The thought of having less people on the street after clubs close is not worth the negatives of a one door policy. I know that other cities have stopped one door policies after a test run, maybe because of similar experiences that I made:

- I experienced that if people know they can't re-enter a club they will stay inside until the club closes. We often stayed for longer than we originally would have: The decision to leave is final as you can't re-enter. Maybe this was stupid rebellion caused by adolescence, maybe this was caused by the principal that every decision you make should provide you with more options, instead of less. Whatever the reason was, it did not lead to emptier streets at night.
- I experienced a significant increase of violence inside of clubs because they were getting more crowded after a one door policy was introduced.
- I had the feeling that people drink rather more than less if they are forced inside by a one door policy and stay inside all the time.
- I personally lost some of my belongings after I helped a friend, who was feeling unwell, getting outside and then wasn't allowed to get back in.
- A friend of mine was separated from our group as she quickly went outside of a club to get some fresh air, not realising that she wasn't allowed to get back in, and she left her coat and purse and mobile inside. She couldn't get hold of any of us and with no money for a taxi she started walking home alone and got raped!

My going out times are pretty much over, but please don't introduce a one door policy. Different closing times of clubs, more taxis and a night shuttle that stops at Bridge street could reduce the issues without the risks of a one door policy. In addition better and brighter street lighting and even playing relaxing music on the street could enhance the behaviors of the people. Please identify options that are safe for people - if even one more girl is raped because of a one door policy, this is the wrong decision.

The New Zealand Medical Association (NZMA) wishes to make a submission on the Draft Nelson City Council Local Alcohol Policy.

The NZMA is the country's largest voluntary pan-professional medical organisation with over 5,000 members. Our members come from all disciplines within the medical profession and include general practitioners, specialists, doctors-in-training and medical students. The NZMA aims to provide leadership of the medical profession, and promote professional unity and values, and the health of New Zealanders.

The NZMA supported the legislation that enabled the development of local alcohol policies (LAPs). We believe that LAPs are necessary to control licensed premises and alcohol availability, as part of a broader package of harm minimising measures. While we congratulate Nelson City Council on the development of a LAP and welcome the proposed restriction on maximum trading hours for off licences, we are disappointed to note that the Council is not seeking greater restrictions on maximum trading hours for on licenses.

The medical profession is on the front lines of seeing the enormous harms incurred from alcohol. There is strong evidence to show that restrictions on maximum trading hours and

curbing outlet density are key ways to reduce alcohol-related harms.<sup>1</sup> We urge the Nelson City Council to engage meaningfully with health professionals when formulating its LAP. The NZMA would be happy to facilitate engagement with medical professionals in the region towards this end, but is not specifically seeking the opportunity to speak to our submission.

## LOCAL ALCOHOL POLICY

### Background

This Submission is made on behalf of the Trailways Hotel, Nelson and De Lorenzo Studio Apartments, Nelson.

1. These facilities in Nelson are owned by the Munro Family who have owned and developed the facilities over the years.
2. The Hotel has 47 guest rooms and the Studio Apartments have 30 guest rooms. The dining facilities cater for 180 guests and we have 1 bar. We have one of the premier Hotel facilities close to the city centre of Nelson. De Lorenzo Studio Apartments are located nearby and are operated in conjunction with the Hotel facility.
3. Currently the Hotel enjoys hours for service of liquor from 11 am to 3 am. The Hotel provides for a lot of the conferences that come to Nelson together with social functions, weddings and, of course, Christmas parties and functions at New Year. The ability to go to 3 am is one of the features that creates demand for our facilities and we are not aware of the Hotel being the source of any problem to the Community that requires your local alcohol policy preventing us for continuing in this fashion.
4. Our Hotel is well utilised and we hold conferences throughout the year which equates to the follow approximate statistics:
  - 22 conferences with 50+ guests – approximately 1,000 pax/800 room nights;
  - 35 conferences with 20+ guests – approximately 700 pax/600 room nights; and
  - 20 conferences with 10+ guests – approximately 200 pax/150 room nights

Our prices are extremely competitive and we are in competition with many other cities throughout New Zealand in order to hold these conferences in Nelson. The availability and supply of alcoholic beverages at the Hotel is always going to be a factor in whether we can hold conferences at the Hotel in the future.

### The Draft LAP

1. The draft seeks to implement blanket provisions for all facilities in Nelson depending on categories and frankly given the nature of our operation, it is hard to see what category we fall into.
2. No reason has been given as to why Nelson City Council sees the need to develop the policy and it does seem to be a knee jerk reaction because of the conduct of a limited amount of premises rather than a city wide problem. It is noteworthy that the Marlborough District Council does not see fit to proceed with such a policy so it cannot be said that Nationwide there is a need for these policies.

3. Like any policy, it does not deal with specific problems but penalises the good because of the bad. In looking at the criteria mentioned, we cannot see how this has been considered in relation to our premises and it certainly does not achieve the third bullet point in paragraph 2.6 of the draft LAP.
4. The status quo was an option or alternatively, instead of blanket policies, greater flexibility could have been built in to encourage the good and well behaved and to deal with the others.
5. Our view is that the net effect will be to discourage Conferences from coming to Nelson and also out of District functions such as weddings. Accordingly, it will effect employment and the quality of life in the long term for Nelson residents and also won't address the problems it seeks to.
6. We wish to be heard in relation to this Submission.

## Plan to fine drunks in Wellington CBD

A drunken stumble down Courtenay Place could become an offence if a proposed initiative is adopted by Wellington city councillors today.

After weeks of debate, councillors will sign off their local alcohol policy at a meeting this morning.

It looks to do away with earlier plans for separate "entertainment precincts", and maximum opening hours for bars and off-licences, and proposes instead to investigate making public intoxication an offence.

The proposal from council officers concedes such a move "fetters people's right to freedom of movement" and would be challenging to enforce, but says a consistent approach across the region could help ensure success.

If passed by the council's strategy and policy committee today, the initiative would return Wellington to the laws of the 1970s, when public drunkenness was outlawed under the Police Offences Act.

# Submission 14

Councillor Iona Pannett has already rejected the idea as "batty". But bar and restaurant owners, who opposed the changes in opening hours, have welcomed it.

Hospitality New Zealand branch president Jeremy Smith said it would reinforce the need for personal responsibility.

"We are big advocates of it. Our approach is saying we are not going to change behaviour and the way people act if there's no consequences or repercussions for the individual.

"At present, the second they step into a bar, the owner and manager gets fined, or their licence confiscated."

Throwing drunks in the cells or arresting them would not be necessary, but an on-the-spot fine and trespass from the central city would be sufficient, Mr Smith said.

"Why don't we treat it like a parking fine? If you come into town intoxicated, then police have the ability to say it's not the behaviour the city wants to encourage.

"Give them a \$50 or \$100 fine and trespass them from the city for 12 to 24 hours, then tell them to go home, sober up and think about things."

The proposal would not be designed to punish responsible drinkers, but instead to get the severely intoxicated off the streets.

"There's a clear difference. It's the type of people who get denied entry to a bar and then get grumpy. They are the ones who get a bit more aggressive and can cause trouble for themselves and others."

But prevention manager Inspector Terry van Dillen, of Wellington police, said officers did not have the resources or time to be dealing with incidents of public drunkenness every weekend.

"That's bottom-of-the-cliff stuff - we need to get to the top of the cliff and encourage real cultural change."

A parking ticket-style approach did not sufficiently tackle the damage caused by the drinking culture, Mr van Dillen said.

"We are punishing people for being drunk, instead of looking at how they got drunk in the first place. But at the end of the day, we will work with the community and partner agencies to do the best we can once the policy is settled."

Council officers have also suggested prioritising a social marketing campaign promoting good behaviour in the central city, focusing on pre-loading and side-loading. Pre-loading is drinking before going into bars and clubs, and side-loading is smuggling alcohol into bars, or hiding it outside for drinking while bar-hopping.

The proposed campaign, modelled on Safe in the City, is estimated to cost \$100,000, and is a response to concerns raised by health officials and police during the local alcohol policy hearings.

## **Disorder drives Hummingbird owners out**

A Courtenay Place hospitality stalwart is bowing out of the business and embarking on a campaign to revitalise a precinct he says has become a haven for the "drunk and disorderly".

Veteran restaurateur John Coleman is bidding farewell to Courtenay Place, but not his passion for Wellington's theatre and night-clubbing quarter.

After more than a decade, the Coleman family are selling their award-winning Blair St corner bar and restaurant Hummingbird, which opened in 2000, and four-year-old Betty's function house and bar.

Mr Coleman has retired from the industry to stand for the Wellington City Council's Eastern ward. The former Courtenay Quarter Accord president said he wanted to see the precinct flourish.

"It needs rejuvenation, and it needs that to show we are the cultural capital," he said. "I am standing up for what I believe in and for our fantastic city, which seems to be languishing under a malaise of indecision and lack of direction."

He said current liquor laws that penalised bars - not "pre-loader" drunks - had made business tough.

"Drunk and disorderly behaviour will not be tolerated and the individual must be held accountable for their actions."

John and Mary Coleman handed management of Hummingbird to their sons last year. The couple had separated, but Mr Coleman said that was not the reason for the sale - he had been motivated by "extremely difficult trading conditions" and his bid for a council seat.

The two businesses are listed separately on Trade Me for a combined asking price of just under \$700,000.

Mr Coleman said times were tough as bar operators were paying for a crackdown on Blair St's troublemakers. Bright lights and security cameras compromised the area's identity instead of addressing problem drinkers, he said.

"It does nothing for the atmosphere and vitality of individual operators who have lost the essential ingredients to their success."

## Submission to Nelson City Council on the Draft Local Alcohol Policy

13 September 2013

**Name of Submitter:** Foodstuffs South Island Limited (Foodstuffs)

1. Foodstuffs are a retailer owned cooperative company, wholly owned by South Island grocery stores. Foodstuffs is New Zealand's leading retail operation and holds 57% of the New Zealand grocery market. As an experienced supermarket operator in the South Island, we have extensive knowledge of liquor retailing to meet the needs of our customers and local community. Foodstuffs are the wholesale supplier to PAK'nSAVE, New World and Four Square supermarkets, Henry's Beer, Wines & Spirits and Liquorland.

### Submission

2. The Sale and Supply of Alcohol Act 2012 introduces significant changes for all off-licence premises and specifically for supermarkets and grocery stores. These changes include:
  - a. the reduction of off-licence trading hours from 24 hours to 7am - 11pm;
  - b. single area provisions; and
  - c. restrictions on advertising, promotion and marketing of alcohol.

Foodstuffs believe it is important to allow the changes of the Act to be implemented and effects measured before further changes are considered.

3. The draft Local Alcohol Policy (LAP) proposes hours for off-licences be restricted to trading hours between 7am - 9pm.
4. One of the objects of the Act is that the harm caused by the excessive or inappropriate consumption of alcohol should be minimised. Foodstuffs does not believe that any evidence has been produced that demonstrates restricting licencing hours from the default hours of 7am to 11pm will lead to minimising harm from alcohol consumption, as there is no evidence that links hours of availability for off-licence premises and time of consumption.
5. Essentially our current trading hours have come about directly as a result of customer demand. Whilst we currently have only one off licence premise operating beyond 9pm, we do not believe there is any evidence to support restricting existing or future premises from the licencing hours set out in The Sale and Supply of Alcohol Act 2012 should customer demand dictate it is necessary to extend store trading hours.
6. Foodstuffs fully appreciates that alcohol is not a normal product and the controls and protocols we put around its sale reflect this fact. However, beer and wine is purchased by supermarket customers as part of their normal weekly shop.

7. Lifestyles in New Zealand have changed dramatically over the decades and will continue to do so. Nowadays we must accommodate shift workers, tag teaming parents, rural work schedules, and busier and busier lifestyles. Further restricting off-licence hours would deny these customers the opportunity to purchase beer and wine during what would be their full weekly shop. This causes inconvenience and is contrary to community retail patterns and demand.
8. Foodstuffs believe that if an LAP restricts off-licence hours the demand for shopping outside the liquor licence hours will inevitably reduce, affecting not just the viability of opening outside of these hours but also directly the lifestyle options of the residents of the community.
9. If customer behaviour and economics force supermarkets to change their trading hours to align with reduced liquor licencing hours there would be unintended consequences with respect to not only community lifestyle, but to current and future employment as well.
10. It is Foodstuffs' submission that the hours for off-licences within the Nelson City Council's Local Alcohol Policy be 7am - 11.00pm.
11. As further restricting the licencing hours:
  - a. will penalise shoppers who purchase beer and wine as part of their normal weekly shop;
  - b. will lead to unintended consequences with respect to community lifestyles and employment; and
  - c. will not achieve the object of the Sale and Supply of Alcohol Act 2012.
12. Foodstuffs would also like to appear to present our submission.

The following clauses in 3.3. Special Licences all seriously impact on the future viability and production values of successful, proven, trouble-free events such as Marchfest, held in the Nelson region:

"No glassware to be taken outside the building or onto grass or artificial grass surfaces" - Marchfest, now in its 7th year, takes place at Founders Park where outdoor grassed areas are an integral part of the event's charm and success.

This stipulation, if implemented would change the character of the event to the extent that it would probably cease to be held in Nelson.

"plastic containers or cans to be used for any event (except when it is being served and remains within the building)" - Marchfest has successfully distributed upmarket souvenir beer and wine glasses to all 2000+ adult attendees without any problems since 2008.

A craft beer event with plastic glasses would be unthinkable for the type of attendee that Marchfest attracts. This stipulation, if implemented would change the character of the event to the extent that it would probably cease to be held in Nelson, if anywhere at all.

"areas to be clearly defined/cordoned off/demarcated where liquor is being sold/consumed outside of the building e.g. Beer tent. Where appropriate people are to remain within the defined area"

This stipulation, if implemented would change the character of the event to the extent that it would probably cease to be held in Nelson, if anywhere at all. We have bars inside and outside on grassy areas - the logistics of how we serve beers at our festival would be seriously impacted by this and increase queuing problems.

"wine to be sold by the glass only and no bottle sales shall occur" - we sell wine by the bottle to tables of attendees without any problems - again this would just be a ridiculous annoyance to the well-behaved people who attend our events.

"the holder of a manager's certificate to be present when alcohol is available for sale, or the number of manager's certificate holders required may be specified" - we have bars inside and outside on grassy areas - having duty managers for every bar would not be financially viable for this event.

"the maximum number of alcoholic drinks per sale transaction may be specified" - the logistics of how we serve beers at our festival would be seriously impacted by this and increase queuing problems.

In conclusion all of the above clauses seem to be based on the kind of alcohol-related outdoor event that have a bad record for alcohol-fueled behaviour. Our event is very different to these, as are Taste Nelson, the Winery Gigs etc etc. The danger is that once these clauses become available, they will be implemented without due regard to the special nature of many Nelson events.

Dear Sirs,

My name is Lee Fern. I am the current owner of the Sprig and Fern in Hardy Street, Nelson CBD. Previous to that I set up and ran the bar at Nelson's Theatre Royal as well as working as General Manager at the Victorian Rose. I have worked in a variety of roles, management and otherwise, in the hospitality industry over the last 33 years both within New Zealand and in Europe. I am currently a HNZ local executive member.

I am proud to say we have a member of the national board on our local executive (Claire Davies) and I am proud also to be part of a hospitality chain which won the title of New Zealand's best bar in last year's hospitality awards (Milton Street). Many bars nationally are adopting the Sprig and Fern model and indeed we are now operating in Auckland and Wellington and seeing likeminded operators appearing. At the recent Brewers Guild awards we were the most awarded brewery in the country for the second time. We also operate in what is considered the brewing capital of New Zealand. I guess my point is that in my own company and amongst my peers we are leaders in hospitality within New Zealand.

With reference to the upcoming law changes within my industry and in particular within Nelson, I believe strongly that Nelson itself also has the ability to be a leader in this country.

My own license currently allows me to trade until 3am. I never or very rarely do. Ordinarily we will close around midnight during the week and around 1am at the weekend. The best tool I have for moving people on when we chose to close is that

they have somewhere else to go.(i.e. Bridge Street). This is almost always on a weekend. On weeknights I am very often the last place open in town even around midnight. It is a hardship to have tourists to our town ask me where they can go next and have to say home. Simply they do not understand. Last week I was fortunate enough to have a conference of geologists visiting Nelson come to my tavern around midnight on 2 occasions and was able to stay open longer, turning what would otherwise have been a very average week into a respectable one. The visitors were needless to say very appreciative. Very few people actually trade to the extent of their allowable trading hours with the exception of weekends but the ability to do so is very important should opportunity arise, to a) satisfy the public wishes and b) to maximise trade sensibly as you would expect in any line of work. I believe the trading hours should be maintained as they are.

We are currently making large investments to attract more overseas visitors to Nelson region to events like cricket, football, and of recent the Rugby World Cup, and rightly so. We have what is becoming a world class education facility in NMIT and are poised to see a large influx of students to the region with this, particularly from Asia. It seems we are making big strides forward in lots of areas yet in hospitality we are in imminent danger of taking a giant step backwards. I read last week in the national press that the government are now looking carefully at options of decreasing penalties on certain drug use because it has become accepted that the future lies not in cure but in prevention (by way of education). I believe this to be the case with alcohol use. We need very much to cure the binge drinking culture but to cure it by education and also by personal responsibility. I have also seen 2 cases of house parties in the North Island, advertised on Facebook, getting out of control and in one case 500 and the other 1000 youngsters, many underage attacking police and property. The result of nobody being able or present to control the sale and supply of alcohol nor to refuse service to underage and intoxicated people. My fear is that we will see more and more of these kinds of unsupervised parties happening if we close venues earlier or the option to enter them is reduced.

As operators in this town we have adopted some strong tactics to address personal responsibility (i.e. the protocol where trespass from one establishment will incur a blanket trespass from all). We also have mellow yellow which has proven its worth, the Know Your Limit Campaign and have secured funding to host more of the police/hospitality breakfast events which really seem to keep communication channels open well. We are definitely proactive in working to address the problems that do exist.

In short let me say I am totally committed to working to improve the experience of a night out for the people of and visitors to Nelson. I would sincerely hope that when finalising our new alcohol policy we can recognise the opportunity to prove to the



rest of the country that we are able to manage our nightlife without feeling the need to punish the very many well behaved people to address the few miscreants.

I am eager to present a verbal submission on this topic to council prior to the LAP being finalised.

Thank you for the opportunity to comment on the Nelson City Council Draft Local Alcohol Policy.

ACC supports the three pillars approach to reducing alcohol related harm of supply control, demand reduction and problem limitation. Local Alcohol Policies are an important tool for supply control and ACC endorses Nelson City Council's effort to restrict supply by implementing a Local Alcohol Policy.

In Nelson, ACC / Ambulance data indicates that the majority of alcohol related injuries occur in the home later in the evenings. As evidence indicates that reducing supply is an important strategy to reduce alcohol related harm, ACC supports council to reduce off licence hours to 9pm from the default provisions in the Sale and Supply of Alcohol Act 2012. Similarly ACC is supportive of council reducing supply in residential neighbourhoods by restricting the issuing of new on-licences unless a resource consent has been granted.

ACC also supports communities to reduce on-licence hours from the default provisions in the Act, particularly when this is supported by community feedback. ACC consequently endorses the draft LAP provisions to reduce bar and tavern hours and the use of a one way door policy if it can be demonstrated that this is effective in reducing alcohol related harm. If a one-way door policy is to be implemented, ACC would support a review of this policy after 12 months to determine its' effectiveness. ACC also supports NCC adopting discretionary conditions that may be applied on a case by case basis for on-licences, special licences and club licences.

ACC would like to speak in person in support of these submissions and will continue to work closely with council on the shared goal of reducing alcohol related harm in Nelson City.

**NELSON DRAFT LOCAL ALCOHOL POLICY**

The Vic has been operating in the CBD for some 20 years, and we have owned the business since August 2010.

We welcome the opportunity to comment on the draft LAP in so far as it affects the business, the local area, and the economic development and wellbeing of Nelson.

From our perspective, the current licensing hours work effectively, which for us is currently 7am to 3am. We normally trade from 11am (summer) 11.45am (winter) till late. We usually trade in winter to at least 11pm, and in summer for up to 2am, except for special occasions such as New Year's Eve when we are more likely to be open until 3am. When we close we often suggest that customers wishing to continue socialising head for other bars, for example in Bridge Street, that usually trade much later.

The current hours provide us with the flexibility we need to be able to offer good quality hospitality in Nelson CBD. In particular we find that tourists and those attending conferences will be seeking the option for later drinking (and sometimes dining). Our experience is that these patrons are responsible drinkers, looking only to enjoy a good night out with friends in an hospitable and safe environment, which I believe that most bars in the CBD provide. This is a very important aspect of the economic wellbeing of Nelson.

We believe that increasing numbers of tourists (hopefully), and the certain increase in conference attendees (following the extension to the Rutherford facility) puts more responsibility on bars and restaurants to meet the needs of late night diners and sensible drinkers.

We believe that our operation at The Vic holds high standards of host responsibility, and that we have a good reputation as a good venue regarding the sale and supply of alcohol. We are therefore anxious that the LAP addresses real issues such as pre-loading, rather than penalises responsible businesses. From our experience pre-loading at home, or on the way into the city is more likely to be the real problem, rather than any shortcomings of licensees.

We do not see any advantage of one-way door policy, and understand that this has produced no benefits in other locations. For us it would mean additional staff cost on the rare occasions we are open beyond 2am, which we feel would be an unreasonable move based on our reputation as a business. Perhaps the authority should look at that policy for individual establishments rather than a blanket policy.

Most Nelson responsible operators belong to the Hospitality and/or Restaurant Association, which both facilitate and promote good operation of business in relation to alcohol. As a member of Hospitality NZ (and a member of the local Executive) I strongly feel that the authorities should take careful note of their view and advice on these issues. As a group we work closely with the police and NCC to ensure the safest and most responsible practices, and in this regard are leaders in the industry.

In conclusion we see no justification for changes to licensing hours or the introduction of a one-way door policy, and feel that the status quo should be maintained. We feel that resources and effort should be focused on policing (a) poor operators and (b) behaviour and practices of intoxicated and pre-loaded people in car parks and streets. This would be of most value to the safety and reputation of Nelson.

I would like to speak to the submission.

### **Draft Nelson City Council Local Alcohol Policy – Submission**

Thank you for the opportunity to provide a submission on this draft policy. We do not wish to speak to this submission.

#### ***Who we are***

Liquorland Limited (**Liquorland**) is a franchised traditional liquor retailer with approximately 80 stores nationally. The shareholding in Liquorland is ultimately owned by the three Foodstuffs co-operatives. The primary business of the Foodstuffs co-operatives is supermarket properties and they operate as a retail cooperative where members are licensed to use the Foodstuffs brands - New World, PAK'nSAVE and Four Square. In 2007 Foodstuffs purchased the Liquorland brand and Franchise.

#### ***What we do to ensure our stores are responsible retailers of alcohol***

It is Liquorland's stated mission to set the standard for liquor retailing in New Zealand. We take this mission very seriously as is evidenced by the slow rate at which we have opened new stores over the last few years despite other traditional liquor retailers being very active opening new stores. We have been slower purely because our hurdles for a potential site and operator are so high. Liquorland supports and believes in the responsible consumption of alcohol as a legitimate and valuable part of society. Liquorland works hard to ensure that it, and every one of its stores, is a responsible retailer of alcohol. As a business, we ensure our franchisees fully understand their obligations under the current legislation regarding the sale of liquor.

We operate thorough training and induction training for new staff and franchisees, with particular focus on legislative obligations regarding the sale of alcohol.

Our point of sale systems prompt the verification of age when an alcohol product is scanned. All stores have an "Under 25: ID required" policy which requires anyone who looks under the age of 25 to provide proof of their age. Additionally, we have an independent programme in place where all of our stores are 'mystery shopped' to ensure proof of age compliance is being adhered to. There are heavy penalties for liquor audit failures, which include fines, additional training programmes and referring repeat offenders to our Board of Directors which can result in a store owner's Franchise Agreement with Liquorland being terminated.



### ***The density of places which sell alcohol***

We support Council's proposal not to impose density restrictions.

Liquorland does not support density provisions that restrict or cap the number of licences in a particular geographic area within the Council wards, beyond any zoning provisions in District Plans. We believe that this provides unfair competitive advantage for stores that are pre-existing or happen to be in one particular geographical area over another.

We believe licences should be considered on their individual merits, rather than being subject to density or location based restrictions. We whole heartedly support the increased hurdles that the Sale and Supply of Alcohol Act 2012 places on new licence applicants and what we believe will be a period of increased retailing standards within the industry.

### ***Proximity to certain facilities or premises***

We support Council's proposal not to impose proximity restrictions. We do not believe our stores, as responsible retailers of alcohol, should be subject to default restrictions regarding opening close to particular facilities or premises. We believe each application should be considered on their individual merits.

Liquorland is committed to responsible liquor retailing and doesn't believe that the vast majority of our responsible customers should be penalised due to the actions of a small minority of the population. Nor do we believe that Liquorland, as a responsible liquor retailer, should be penalised because of liquor retailers that do not hold our high standards.

We believe that a number of provisions introduced by the new legislation such as improved definition of what constitutes a grocery store, new criteria for licences and renewals including good order and amenity consideration, and the '3-strikes rule' (3 convictions for certain offences and the licence holder cannot hold a liquor licence for 5 years) are likely to be sufficient to address many instances of alcohol related harm arising from irresponsible alcohol retailing.

Council and the Police have other powers that can be exercised to curb issues of alcohol abuse in specific broad public areas. Examples of these initiatives include liquor bans, arresting people who are disorderly in public and enforcing the provisions within the Sale and Supply of Alcohol Act 2012.

### ***Opening hours***

We are responding in relation to off-licences only. Liquorland believes the maximum default hours in the new legislation, which have the sanction of Parliament, of 7am-11pm are appropriate. As far as we are aware there is no firm evidence that supports an argument that by restricting off-licence hours that alcohol harm is reduced.

To the extent Council wishes to amend this we would encourage consistent hours across the entire district and all types of off-licences.
