# 3. Mayor's Report

The Mayor advised the meeting will continue in public session until lunch time, go into public excluded after lunch, and then deal with any remaining public items but still finish at 3.00pm.

# 4. Strike the Rates - Annual Plan 2011/12

The rates resolution was tabled (1033816).

The Chief Executive advised that there were some minor wording changes needed to the final Annual Plan concerning wording that had been erroneously changed in the draft Annual Plan Funding Impact Statement and recommended that this be added as part of the rates resolution.

## Resolved

<u>THAT</u> the Nelson City Council set the following rates under the Local Government (Rating) Act 2002, on rating units in the district for the financial year commencing on 1 July 2011 and ending on 30 June 2012. All figures are GST inclusive.

# (1) General Rate

A general rate set under section 13 of the Local Government (Rating) Act 2002, assessed on a differential land value basis as described below:

 a rate of 0.56025 cents in the dollar of land value on every rating unit in the "residential" category

- a rate of 0.61628 cents in the dollar of land value on every rating unit in the "part nonrateable" category
- a rate of 0.61628 cents in the dollar of land value on every rating unit in the "multi residential" category
- a rate of 1.22135 cents in the dollar of land value on every rating unit in the "commercial outside the inner city zone" category
- a rate of 1.05607 cents in the dollar of land value on every rating unit in the "commercial outside the inner city zone subject to 25% residential & 75% commercial" category
- a rate of 0.89080 cents in the dollar of land value on every rating unit in the "commercial outside the inner city zone subject to 50% residential & 50% commercial" category
- a rate of 0.72553 cents in the dollar of land value on every rating unit in the "commercial outside the inner city zone subject to 75% residential & 25% commercial" category
- a rate of 1.74238 cents in the dollar of land value on every rating unit in the "commercial inside the inner city zone" category
- a rate of 1.44713 cents in the dollar of land value on every rating unit in the "commercial inside the inner city zone subject to 25% residential & 75% commercial" category
- a rate of 1.15132 cents in the dollar of land value on every rating unit in the "commercial inside the inner city zone subject to 50% residential & 50% commercial" category
- a rate of 0.85606 cents in the dollar of land value on every rating unit in the "commercial inside the inner city zone subject to 75% residential & 25% commercial" category
- a rate of 0.36416 cents in the dollar of land value on every rating unit in the "rural" category
- a rate of 0.50423 cents in the dollar of land value on every rating unit in the "small holding" category

# (2) Uniform Annual General Charge

A uniform annual general charge under section 15 of the Local Government (Rating) Act 2002 of \$340.80 per separately used or habitable portion of a rating unit, (excluding properties subject to statutory declarations for unoccupied or second residential units not being used as separate units).

# (3) Separate General Charge - Stormwater

A targeted rate under section 16 of the Local Government (Rating Act) 2002 of \$240.30 per rating unit, (excluding rural category, small holding category east of Gentle Annie, residential properties east of Gentle Annie saddle, Saxton's Island and properties subject to statutory declarations for unoccupied or second residential units not being used as separate units).

# (4) Waste Water Charge

A targeted rate for waste water disposal under section 16 of the Local Government (Rating) Act 2002 of:

- \$353.10 per separately used or habitable portion of a residential rating unit, (excluding properties subject to statutory declarations for unoccupied or second residential units not being used as separate units), that is connected either directly or through a private drain to a public waste water drain
- For non-residential rating units, a waste water charge of \$353.10 per separately used or habitable portion of a rating unit that is connected either directly or through a private drain to a public waste water drain and a "trade" waste charge will be levied

# (5) Water Supply Charges

A targeted rate for water supply under Section 19 of the Local Government (Rating) Act 2002, of:

• A minimum annual charge \$187.17

• Price of water:

0 - 10,000 cu.m/year \$1.862 per m<sup>3</sup>

10,001 - 100,000 cu.m/year \$1.507 per m<sup>3</sup>

• Summer irrigation

\$1.684 per m<sup>3</sup>

# (6) Clean Heat Warm Homes

A targeted rate per separately used or habitable portion of a rating unit that has been provided with home insulation and/or a heater to replace a non-complying solid fuel burner under Section 16 of the Local Government (Rating) Act 2002, of:

- For properties levied the Clean Heat Warm Homes charge after 1 July 2011, the targeted rate for each year for 10 years will be the total cost of the installed works excluding GST, divided by 10, plus GST.

# (7) Solar Hot Water Systems

A targeted rate per separately used or habitable portion of a rating unit that has been provided with financial assistance to install a solar hot water system under Section 16 of the Local Government (Rating) Act 2002, of:

• 0.14964 multiplied by the Net Cost of the Work.

# (8) Postponement Application Charge

A targeted rate for rates postponement application charges under Section 16 of the Local Government (Rating) Act 2002, of \$400.00 per rating unit that commenced rates postponement during the 2010/11 rating year.

# (9) Postponement Interest Charge

A targeted rate for rates postponement interest charges under Section 16 of the Local Government (Rating) Act 2002 per rating unit based on the 2011/12 rates levied and any outstanding balance from previous rating years, of:

•	Interest charge	6.75%pa
•	Reserve fund	0.25%pa
•	Scheme application fee	1.00%pa

# Differential Categories

The Nelson City Council adopts the following as its definition for its differential categories for the 2011/12 financial year:

## (1) General Rate

- Residential all rating units that are used primarily for residential purposes
- Multi Residential all rating units that contain more than one residential dwelling that are cape able of being used primarily for residential purposes

- Commercial any rating unit which is used primarily for commercial use. Properties that have a portion of residential use shall have a reduced commercial differential
- Commercial Inner City Zone any rating unit which is used primarily for commercial use that is located within the Inner City Zone. Properties that have a portion of residential use shall have a reduced inner city commercial differential
- Rural any rating unit having an area greater than 15 hectares which is used primarily for dairy, fattening and grazing, quarries, forestry or horticultural use and is recorded as rural on the District Valuation Roll
- Small Holding any rating unit which is primarily used as a small holding and having an area greater than 5,000m2 but is less than 15 hectares and is recorded as a small holding on the District Valuation Roll

Special (final) water rates will be due and payable 14 days from the date of the special (final) water reading.

Commercial water rates are payable at the Nelson City Council office, 110 Trafalgar Street, Nelson on the 20<sup>th</sup> of the month following the date shown on the water invoice.

## Penalty on Rates

Pursuant to Sections 57 & 58 of the Local Government (Rating) Act 2002, the council delegates authority to the Chief Financial Officer to apply the following penalties on unpaid rates (including water accounts) at their discretion:

- a first additional charge of 10% of the amount of each rate instalment remaining unpaid on the penalty date as shown on each rate instalment notice.
- a second additional charge of 10% will be added to any balance remaining outstanding from a previous rating year (including penalties previously charged) as at 31<sup>st</sup> December 2011
- a further additional charge of 10% will be added to any balance remaining outstanding from a previous rating year (including penalties previously charged) as at 30 June 2012
- The above penalties will not be charged where Council has agreed to a program for payment of outstanding rates.

# **Penalty Remission**

In accordance with Council's rate remission policy, the council will approve the remission of the penalty levied on instalment one due to late payment provided the total annual rates are paid in full by 28 November 2011. If full payment of the annual rates is not paid by 28 November 2011 the penalties relating to the first instalment outlined above will apply.

# Discount on Rates

Pursuant to Section 55 of the Local Government (Rating) Act 2002, the Council will allow a discount of 2.0 percent of the total rates (excluding water charges) where a ratepayer pays the year's rates in full on or before the penalty date for instalment one being 29 August 2011.

# Payment of Rates

The rates shall be payable at the Council offices, Civic House, 110 Trafalgar Street, Nelson between the hours of 8.30am to 5.00pm Monday to Friday. Where any payment is made by a ratepayer that is less than the amount now payable, the Council will apply the payment firstly to any rates outstanding from previous rating years and then proportionately across all current year rates due.

AND THAT the word habitable be corrected to inhabited and the sentence describing the definition of the separately used or inhabited parts of a rating unit, "A 'unit of occupancy' is defined as being separately let and permanently occupied", be reinserted into the 'Funding Impact Statement' of the 2011/12 Annual Plan to be consistent with the 2009 LTCCP.

# 12.1 Request from the Regional Transport Committee

Councillor Barker spoke on the background to the recommendation from the Regional Transport Committee (RTC).

The staff recommendation was moved by Councillor Davy and seconded by Councillor Collingwood.

<u>THAT</u> Council advise the Regional Transport Committee that they have considered their request 'that the Minister of Transport permit locally gathered fuel tax ('R' Funding) by all Unitary and Regional Councils to be used to implement their respective Regional Transport Strategies' but do not support it at this time.

There was considerable discussion around 'R' Funding and the role of the RTC.

The Principal Adviser Transport and Roading, Andrew James, spoke on the clearly defined Government guidelines on how 'R' Funding could be spent. He advised that any projects would need to have been fully funded and constructed by 2015.

Mr James added that the Government had recently announced that the structure of regional transport committees would be changing.

The Chief Executive clarified the ownership and membership of the RTC and spoke further on the significance of the Government announcement.

12.3 High Productivity Motor Vehicle Routes

The Principal Adviser Transport and Roading, Andrew James spoke to the report and was joined by Jason Morgan and Tim Siau from the New Zealand Transport Agency.

Mr Morgan confirmed the new limits for vehicles in terms of length and capacity. He advised that they were considering the strength of roads and structures in terms of safety.

Mr Morgan also spoke on the permitting system which meant that permits had to be agreed on as a region. He confirmed that the Top of the South study was not finalised but that all safety and infrastructure points were identified as compliant, which is why the recommendation was coming to Councillors before the study was completed.

Mr Morgan said that the study was now due to be completed by the end of July 2011 and that the Jenkins Bridge was to be strengthened by June 2012.

Councillor Shaw put forward an amendment that the recommendation be left to lie on the table, which was seconded by Councillor Boswijk.

There was further discussion on the matter and it was confirmed by Mr Morgan that no new information in relation to the study would be generated.

Councillor Shaw's amendment was put and lost.

The original staff recommendation was then put and carried.

### Resolved
