## 3.2 Heart of Nelson (HON) projects update

It was noted that, if not there already, the Wayfinding signs will be made available on the Council website.

The Principal Adviser Transport and Roading, Andrew James joined the meeting. He said staff will present a report to Council in the coming months with detail about the parking on Vanguard Street, particularly in regard to the lay-by opposite Harvey Norman. The report will include information about the consultation with residents in the area, he added.

The Council heard that the delegation to decide the artwork that will be placed at the QEII Gateway (agenda page 4 refers) is with the Arts Panel, however details of the chosen piece will be circulated to Councillors.

There was concern expressed at the lack of toilet facilities at the Cathedral, which is a key attraction for Nelson (agenda page 8 refers). The Principal Adviser Reserves and Community Facilities, Andrew Petheram joined the meeting and said staff had concerns about security at the original site on Church Hill. Instead, a more suitable site on Selwyn Place had been chosen.

It was confirmed that the funds resulting from the decision to not install solar heating improvements at the Maitai Camp will be used for other Council solar installations and would form part of the Annual Plan discussions.

The Executive Manager Network Services, Alec Louverdis said staff would exercise best endeavours to complete the Marina Toilet/Shower facility (agenda page 14 refers) before the RWC 2011 but noted the project was spread over two financial years.
