1. Opening Prayer

The opening prayer was given by Councillor Davy.

2. Conflicts of Interest

No updates to the Conflicts of Interest Register or any conflicts of interest with the agenda were identified.

3. Public Forum

Nelson Railway Society

Mr Ray Carter and Mr Bob Murray, from the Nelson Railway Society, showed a short video of the railway at Founders Park and made a powerpoint presentation (document 1254167).

Mr Carter tabled a paper (document 1256891) summarising the Society's request to Council for a railway right extension and rules for construction and the operation of the railway to be included in the Long Term Plan.

The document also requested that the Council undertake a Plan Change to provide a rail corridor from Sovereign Street, across Trafalgar Street, behind Trafalgar Park, Hathaway Court and Trailways near Trafalgar Street Bridge, and to provide for the Nelson Railway Society to construct and operate the railway.

In answer to a question, Mr Murray confirmed that in his view, should the Nelson Railway Society be allowed to lay track across water mains, in the event of something happening to that water main, it would only take the Society two or three hours to lift the track, so any repairs or maintenance could be carried out.

His Worship the Mayor thanked Mr Carter and Mr Murray for their presentation and said that their tabled document would be put as a submission to the forthcoming draft Long Term Plan.

4. Mayor's Report

4.1 Council Meeting 7 March 2012- Failed For Want Of A Quorum

In answer to a question from, the Acting Chief Executive said that because the Council meeting on Wednesday 7 March 2012 had failed for lack of a quorum the meeting would now be held on 30 March 2012.

4.2 Receiving Minutes at Council Meetings

There was some discussion regarding the benefits of receiving minutes from respective Council meetings at the next meeting of that Council meeting i.e. the Infrastructure minutes should be received at Infrastructure Council meetings, the Governance minutes should be received at Governance Council meetings etc. It was agreed that in future this practice would be adopted.

She presented her with a card that had been signed by all Councillors wishing her the very best for the future.

7. Chief Executive Report - Infrastructure

The Councillors went through the report section by section.

7.1 Minor Safety Projects Update

There was discussion regarding issues with the traffic lights at Tahunanui and in particular the proposed State Highway 6/Tahunanui Drive pedestrian crossing near Muritai Street.

The Principal Adviser Transport and Roading, Andrew James, joined the meeting and explained that the situation on that stretch of road was very complex and that the New Zealand Transport Agency was currently working through all the issues. Mr James added that although he had noted Council's concerns, the road is State Highway and not under Council's control.

It was agreed that a letter would be sent to the New Zealand Transport Agency outlining Council's concerns and explaining the urgency for a solution.

7.2 Parking and Vehicle Control Bylaw 2011, No 207 Amendments to Schedules.

8. Rutherford and Trafalgar Parks Development Plan (including the Maitai Walkway)

Document No. 1239031, agenda pages 10-46 refer.

The Principal Adviser Reserves and Community Facilities, Andrew Petheram, together with the Planning Adviser, Britta Hietz, and Megan Wraight, from Wraight and Associates Ltd, joined the meeting.

Mr Petheram introduced the report saying that the proposal would take many years to complete and specific projects and their funding would go through Council's Long Term Plans and Annual Plans as appropriate.

Ms Wraight gave a Powerpoint presentation.

An updated Rutherford & Trafalgar Parks Concept plan (Document number 1238139) was tabled.

The discussion focused on what were described as Option 1 and Option 2. Option 1 proposed that the existing Haven Road carriageway from the Halifax Street roundabout to the QEII roundabout be reduced to one lane in each direction with the existing second lane being used for carparking and as an access/drop off/pick up to Auckland Point School, where it was in the vicinity of the School.

Option 2 proposed the closing of the two carriageways that were adjacent to Saltwater Creek bringing traffic into town and grassing this area and creating two way traffic on the carriageway that currently takes traffic out of town.

During discussion, it was pointed out that Council was committed to the resolution it had passed to preserve the future arterial option.

Councillor Davy moved and Councillor Matheson seconded the first two parts of the recommendation in the report with the addition of the words 'in principle subject to Long Term Plan consultation' being inserted at the end of the first paragraph.

It was agreed that the third part of the recommendation would be considered separately.

Councillor Copeland moved and Councillor Fulton seconded an amendment

AND THAT Council approves that design and preliminary works commence in the current (2011/12) financial year (subject to New Zealand Transport Agency funding its share of the emergency works) as part of the funding set aside for recovery work;

AND THAT Council include funding to undertake these works estimated at \$1,912,000 (subject to New Zealand Transport Agency funding its share of the emergency works) in the Long Term Plan for 2012/13 to effect re-instatement to the previous level of service;

<u>AND THAT</u> Council contributes up to \$2500 towards fencing of slip areas to prevent stock access for soil conservation purposes through the land management fencing grant scheme;

<u>AND THAT</u> staff investigate the costs and implications of funding reseeding or replanting of the area of immediate road bank and farmland fenced off from grazing by Ian and Barbara Stuart;

<u>AND THAT</u> Council open the road to all traffic but keep the caution signs and traffic lights in place until the repair work commences.
