Her Worship the Mayor spoke to the information items in the report. In response to a question, the Mayor said there was about \$4,000 left in the Mayoral Fund. She further added that individuals could approach her with applications for this discretionary funding.

Her Worship the Mayor emphasised opportunities to input into economic development initiatives for Nelson through the Regional Sector Group Meetings.

There was discussion about the Council's role in limiting the availability of sugar sweetened beverages at Council sites and a variety of opinions were expressed both for and against work in this area.

It was suggested that this would help councillors keep up to date with the views of represented groups, and that the groups would be supportive of this approach as they could be involved in the Council process.

Another view suggested that scheduled meetings of a Committee or Council should include a standing item to allow reporting back from one councillor at each meeting. Councillor Acland, seconded by Councillor McGurk moved a motion

The motion was put and was lost.

The Acting Group Manager Environment, Greg Carlyon, joined the meeting and gave a demonstration on the LAWA (Land Air Water Aotearoa) website (www.lawa.org.nz). He explained how the tools in the website could illustrate water quality at different sections, and at separate stages, of the waterways in the Nelson area. He outlined how this information could be used and said the website could showcase logs and follow up reports after a significant weather or other event.

Mr Carlyon said that water quantity was likely to be the second module added to the website. In response to a question, Mr Carlyon said the levels of health of Nelson waterways on the website were compared against recognised national standards.

12.1 Nelson Air Quality Plan and Woodburner Review

#### 14.1 Independent Review – Southern End, Trafalgar Centre

There was a discussion about 'significant Council projects' as noted in the officer recommendation, and whether a policy was needed to identify significant projects.

The Chief Executive said that such projects were considered to be of high political profile, expenditure or other sensitive nature, and were not assessed in terms of the Council's Significance Policy. She also added that a business case approach would be part of the reporting to Council on significant projects.

Councillors discussed what was expected in terms of reporting on significant projects, and agreed that its identification depended on a threshold being achieved in terms of its significance. It was agreed that it was not cost-effective to consider a business case approach for all Council projects, and that differentiation with significant projects was required.

Her Worship the Mayor, seconded by Councillor Barker moved an amendment to add the following clause to the final motion

<u>AND THAT</u> through the Long Term Plan/Annual Plan development, Council will give consideration to the projects that will follow a business case approach.

The Council debated the amendment. Councillors further noted the administrative costs involved in applying a business case approach to all projects, yet agreed that the advice in the Bickers report (attached to the officer report) was important and should be applied to significant projects.

In response to questions, the Chief Executive further clarified that the Council's Significance Policy currently identified work programmes where Council proposed a change to levels of service resulting in the requirement for a special consultative procedure, and noted that this was different to the current discussion about significant projects.

The amendment was put and carried. The Council then considered the substantive motion.

#### Resolved

<u>THAT</u> Council accept the recommendations in Alan Bickers' report dated April 2014 (A1180082);

AND THAT Council note the business case approach to projects, as set out in the Independent Review of the Southern End, Trafalgar Centre, will be reviewed and
